FREQUENTLY ASKED QUESTIONS (FAQ)

About the Volunteer Program

The volunteer program was established to provide hands-on experience for individuals interested in supporting their community. We currently have openings for core volunteers, who serve via emergency response functions.

Types of Volunteers & Minimum Requirements

Q. What is the role of a CORE volunteer?

- A. The core volunteers support their community in an emergency response role. Duties include:

Drills, Classroom Training, Field Training

Core volunteers participate in fire and EMS related drills, and attend classes to attain and maintain necessary skills related to fire suppression, life safety, rescue operations, property conservation operations, clean-up projects, and other related activities.

Fire & EMS Service

Rehab unit staffing and response, medic standby, and water tender operations; responding to alarms; performing firefighter related duties, including the use of hoses, pumps, equipment, emergency apparatus, and tools; maintaining and testing apparatus, equipment, and facilities.

Community Activities

Participating in community activities, public education, standbys, fire watches, station tours, and other events that require positive public interaction.

Q. What are the requirements for a CORE volunteer?

A. The minimum requirements are:

- Must be 18 years of age or older.
- High school graduate or equivalent required.
- Must have a valid Oregon driver's license.
- Must pass criminal background check, reference check, pre-academy physical exam, and drug screen.
- Must live within TVF&R jurisdiction. See "About Us" at www.tvfr.com for TVF&R service area information.
- Must attend and successfully complete 100% of the academy, approximately six to ten weekends.
- Must be Fire Fighter I certified or have Fire Fighter I certification within one year of becoming a volunteer. District provided training.
- Must be an Oregon EMT-Basic or receive EMT-Basic certification within one year of becoming a volunteer. EMT-B certification costs may be reimbursed upon completion.

Successful candidates will also have the following:

- Key characteristics well suited to the philosophy and values of the District, including a strong community and customer-service orientation and high level of professionalism.
- Demonstrated use of good judgment and decision making.
- Excellent physical conditioning.
- An "unremarkable" criminal background and driving record.

EMT Status

Q. Do you have to be EMT-B or EMT-P certified in the state of Oregon to be a combat volunteer?

A. It is required for Core volunteers, though not at the time of application. Core volunteers are required to obtain their certification within one year of graduating from the volunteer academy.

Q. How will you verify my EMT status?

A. If you advance further into the hiring process, you must be able to show proof of EMT-B certification, proof of EMT-B course enrollment, or proof that you meet

the basic math and English requirements to enroll in an EMT course at a local community college.

Q. How do I obtain proof that I am eligible to enroll in an EMT course?

- A. You can obtain confirmation by taking an Asset Test at a community college. Contact the Portland Community College office at 503-244-6111 to set up an appointment, or you may contact one of the other community colleges of your choice.

Q. What if my EMT certification is from out of state?

- A. If your certification is out of state, you should contact the State of Oregon Department of Human Services (Emergency Medical Services & Trauma Systems) to request the paperwork to establish reciprocity.

Application Process

Q. Can I turn in an application any time?

- A. No. Applications for TVF&R Volunteer Recruit Academy, beginning in August 2010, were only accepted from April 5, 2010 through April 26, 2010. You may place your name and contact information on our interest list at any other time throughout the year.

Q. When is the application due for the August 2010 Academy?

- A. The application must have been received no later than 4:30 PM on April 26, 2010.

Q. Is it okay to hand-deliver the application?

- A. Yes, during open recruitment periods applications may be hand-delivered to the TVF&R Command & Business Operations Center, located at 20665 SW Blanton St., Aloha, OR 97007. Office hours are 8am-4.30pm, Monday through Friday (excluding holidays). There is also a mail slot located on the front of the building; you may drop your application there after hours.

Q. Will you notify me when you receive my application?

- A. Yes, we will email you when we receive your online application form or if you attach the application to an email and email it to jobs@tvfr.com. If you mail or hand-deliver the application, you will not hear from us until we schedule a phone interview.

Q. What are your Administrative Office hours?

- A. We are open 8am-4.30pm, Monday through Friday (excluding holidays). You may also drop your application in the mail slot located by the front door.

Q. How many volunteers do you typically accept each year?

- A. The number of volunteers we accept each year depends on the number of vacancies at each volunteer station. For the August 2010 Academy, we anticipate bringing on 5-8 Core Volunteers.

Q. Do I need to live in the TVF&R District to serve as a volunteer?

- A. Yes, you are only eligible to become a TVF&R volunteer if you live within the TVF&R District boundaries (see our “About Us” on www.tvfr.com for more boundary information). To determine whether your address is within the TVF&R District, go to www.portlandmaps.com, enter your home address, click on the Assessor tab, and verify that TVF&R is listed under *Fire*.

Selection Process

Q. When will I know the status of my application?

- A. For the August 2010 academy, we expect that phone screening will be complete by the middle of May. An email informing you of your status will likely be sent at that time.

Q. What if I don't receive an email by the middle of May?

- A. Please call our Command & Business Operations Center at (503) 649-8577 to determine your status.

Q. When are Chief's Interviews?

- A. Interviews have been scheduled for the evening of Tuesday, May 25. If you are invited to the interviews, you will receive an email informing you of your interview check-in time.

Q. Will I receive a Chief's interview?

- A. Core Volunteer applicants that applied within the opening dates (position closed April 26, 2010), met the minimum qualifications, and followed the application instructions, were eligible for a phone interview. The list of individuals moving forward to Chief's interviews will be determined through the phone screening. After the phone interviews are complete all candidates that applied will receive an email notifying them of their status.

Q. Why was I disqualified?

- A. There were many applicants that did not meet the minimum qualifications. Most of those disqualified candidates lived outside of our District boundaries. A primary requirement was that candidates must live within the District jurisdiction. Candidates also must have a VALID drivers license, if your license is not valid, you did not meet the minimum qualifications.

Candidates were required to complete the application in full. If your application was missing the requested information, it was not considered.

If you received a phone interview, and you were not selected to move forward to the Chief's interviews: You met the minimum qualifications; however, there were many qualified applicants and only a few were selected to move forward to the interview process. We chose the candidates that best exhibited to us that they would be a good fit within our organization.

Academy Schedule

Q. When, and how long, is the TVF&R Volunteer Academy?

- A. The next TVFR academy begins on August 21, 2010.

Academy Schedule:

2 weekends, 32 hours.

Additionally, core volunteers will be required to attend the Firefighter 1 Academy for 8 weeks beginning September, 2010.

The FF1 Academy will likely be on weekends and one evening each week.

Miscellaneous

Q. I have some convictions and some traffic violations in my history. How do I know if those will disqualify me from consideration?

A. TVF&R does not apply any blanket policy to consideration of candidate conviction histories and driving records, but reviews circumstances on a case-by-case basis. Our considerations take into mind the obligations we owe to our citizens to protect them as well as what a conviction history and/or driving record says about a candidate's judgment, respect for the law, maturity and general character. Crimes against persons as well as property crimes are taken very seriously due to the access our volunteers have to persons and homes when called to a scene.

Q. I have some significant convictions in my past, but they do not represent the person I am today. How can I make sure those don't pose an obstacle to being selected for appointment?

A. You must make a compelling case for why the District should consider you in light of your conviction history. You may do this on the application itself, or if you feel you can be more effective by attaching a separate statement, that is encouraged.

Q. If I live outside of TVF&R's boundary, but really close to one of your stations, can I apply?

A. Unfortunately, no. You are not eligible to apply unless you live within our service boundary.

Q. I don't live within your District, but if I'm accepted as a volunteer, I will move into your District. Is that okay?

A. Unfortunately, no. You are not eligible unless you live within our service boundary. However, we anticipate future recruitments and you may apply once you reside within the District service area.

Q. If I have already been a volunteer at another fire department, do I still have to go through the entire academy?

A. Yes. All volunteer recruits must complete all required training, including the TVF&R academy.

Q. Do you have an Explorer or Cadet Program?

A. At this point we do not have an Explorer or Cadet program.

Q. Is there any age requirement?

A. Volunteers must be age 18 or older.

Q. How much do volunteers get paid?

A. IRS rules preclude us from paying our volunteers. However, we make every effort to reimburse for any expenses (the law allows) that you may incur while volunteering for us. One example of this is that we reimburse for mileage from your home to your station.

Q. I've heard that you reimburse for college, how does that work?

A. Yes this is one of the benefits of being a Core volunteer. With preapproval you may be eligible for reimbursement of classes that relate to fire service.
