Lt. Michael Balfour, who was serving in a Limited Administrative Assignment focused on outreach, returned to the line sooner than expected. However, he successfully pursued priority partnerships with five regional colleges. Lt. Balfour visited each school and presented to classes of EMT, paramedic, and fire science students. He encouraged over 100 students to join our Attract database, enabling us to continue engagement and connect them with opportunities matching their interests. These efforts also increased the number of students applying for our Firefighter Intern Program.
